Finances, capital improvements focus of recent Board action



Greetings from the Board of Education! There are many positive things go-

ing on in the district and we wanted to make you aware of some of them.

We received good news from our financial advisers, George K. Baum, on the refinancing of our 2007 General Obligation bonds. We were able to reduce the interest costs by approximately 2% yearly for the remaining term of the debt. This translates into a savings of \$930,000.00 over 10 years for

the district. We, as a district, also maintained our AA- rating from Standard & Poors. This rating places us among the top 20 to 25 districts in the state, and the main factors for this rating are the financial management of the district as well as local demographics and economic stability.

A new application process is being used to make repairs to the roof at Harrisonville Elementary School. It is our hope that by the time the spring rains come, all issues will be resolved. This application may be replicated in other areas as they present themselves. The district recently completed a facility needs assessment. The administration has reviewed and will continue to review this document. The facility needs

assessment will be used as a basis for determining future building needs and capital improvement projects. The turf installation at Memorial Stadium is complete and looks amazing. Our current capital projects are all moving forward as expected.

State testing is just around the corner and we wish our teachers and students well. It is a stressful time and we want them to know they will be in our thoughts. We as a Board would like to thank our staff for the work they do. If they were not part of the team, the education and experience of our students would be lessened.

The newly appointed board members are settling in and earnestly striving to learn the ropes, including school finance, board governance and policy. Each brings their own individual strengths to the table which will continue to move us forward to achieve what is best for the district. With the election coming up, we will again have new board members coming on, and we will continue to work together for the best interest of the students and staff.

We have an awesome and dedicated team and we want to thank the community for their continued support!

All other students must be picked up at ECC.

Incoming 1st-6th Graders will attend Summer School at McEowen; the hours are 8 a.m. - 2:30 p.m. Breakfast and lunch will be provided.

The Community Center will once again offer after-school care for a fee. The district will provide transportation to the Community Center.

The high school will be offering several online opportunities during June.

Enrollment information was emailed to parents of elementary school students the week of March 20 and is available on the district website. Completed forms are due back by Friday, April 7.

Drivers Education available in June

The Cass Career Center Community Education program will once again offer Drivers Education.

The two-week class will help prepare teens and new drivers for the Missouri behind-the-wheel driving test. The class consists of 15 hours of classroom instruction, as well as six hours of in-car observation and three hours of behind-the-wheel drive time. Students must be 15 years of age with a permit.

The class begins with classroom lecture from 9 a.m.-12 p.m., May 30-June 5.

The second week will be ob-

To be eligible for kindergarten, children must be five years of age before August 1, 2017 and must live in the Harrisonville school district. Parents must bring a certified copy of the child's state issued birth certificate and his/her current immunization records to enrollment. A proof of residency such as a current utility bill will be required in August.

Preschool enrollment for 3- and 4-year-olds will start on April 24 at 6

p.m. at the Early Childhood Center.

Children who turn three by August 1 have the option of Monday/ Tuesday morning classes or Monday/ Tuesday afternoon classes.

Children who turn four by August 1 have the option to attend

Wednesday-Friday morning classes or Wednesday-Friday afternoon classes.

Foundation supports staff, students through grants, scholarships

The Harrisonville Public School Foundation supports the students and teachers in the school district through multiple programs. The Foundation presents funds to teachers in the form of teacher grants and the advanced degree teacher reimbursement program. Seniors are eligible to receive scholarships from the Foundation and the Foundation also provides funding for students to attend the Hugh O'Brian Youth Leadership Academy and the Missouri Scholars Academy.

This spring, the Foundation presented more than \$3,700 in teacher grants. Throughout the 13 years of the teacher grant program, more than \$80,000 has been presented to teachers. The goal of the program is to enhance the education of Harrisonville students by encouraging and recognizing new educational approaches and concepts that are not currently funded by the district.

The grants were awarded in a surprise squad format with Foundation trustees surprising the teachers in their classrooms and presenting them with a check. Teacher grants were awarded to the following:

- Rebecca Reeser, speech/language teacher at McEowen Elementary School, for additional technology in the form of a TV to be hooked to a teacher laptop for use in meetings with staff, parents, and students to cut down on the use of paper and provide the ability to use live working documents.
- Brian Graber, counselor at Harrisonville Elementary School, for counseling curriculum for third grade which is in line with the counseling curriculum for K-2 previously funded by the Foundation. This grant was funded through the Cade Filer Teacher Grant Endowment.
- Kim Spencer, fourth grade

teacher at McEowen Elementary School, for math manipulatives for handson learning to provide a physical understanding of what math concepts look like.

- Marla Brown, fourth grade teacher at McEowen Elementary School, for classroom sets of four books to provide opportunities for sharing and discussion of literature in the classroom setting. All books have a focus on positive character traits and acceptance of others. (Pictured)
- Gail Howe, ELL teacher at Harrisonville Middle School, for Chromebooks for use with students who

have limited language proficiency providing unlimited resources to supplement basic knowledge, cultural factors, translation, and comprehension.

In addition, this spring, the Foundation passed out \$1,300 through the Advanced Degree Teacher Reimbursement program to teachers seeking advanced degrees in non-administrative fields. Teachers can apply for \$25 per credit hour up to six hours per semester. The Foundation has presented more than \$28,000 since the program began.

Elementary schools in the district also received funds from the Foundation's annual Major Saver discount card sales. The proceeds are split 50/50 between the participating schools and the Foundation. ECC received a check for \$1,890; HES earned \$4,350; and McEowen was presented a check for \$2,193.75.



Three Harrisonville High School students will participate in a leadership conference in this summer thanks to funding from the Harrisonville Public School Foundation. Haley Holden, Peyton Zaring, and Sam East will attend the Hugh O'Brian State Leadership Seminar. The students were selected by the HHS staff for this opportunity. The Leadership Seminar is "designed to help high school sophomores recognize their leadership talents and apply them to become effective, ethical leaders in their home, school, workplace and community." HOBY will be held June 16-18 at Southeast Missouri State University in Cape Girardeau.

Harrisonville High School seniors can apply for scholarships managed by the Foundation. Ten scholarships are available totaling \$22,300. The application deadline for the Foundation scholarships is April 13. Information on the schol-

arships and the application is available online at www. harrisonvilleschools.org/foundation

Seniors who earn the Excellence in Academics award for the fourth year will also be eligible for a \$500 scholarship from the Foundation. The Excellence in Academics award is presented to those students who finish the year in the top 15% of their class. The award is based on annual GPA, not cumulative. Four-year recipients can choose to accept the \$500 scholarship or donate it to a district program.

Boots & Bar-B-Que to raise funds for trauma simulation manikin

event is \$60,000. Proceeds will be used to purchase a trauma patient simulator. The simulator, which is a manikin, will provide ongoing training and preparedness for staff at Cass Regional Medical Center.

"The simulation manikin will allow our staff to practice procedures to treat trauma injuries that we don't see often," Trauma Program Coordinator Paula McBride, RN, CEN, said. "It will also allow our staff to see the results of their actions."

The manikin, called Trauma HAL, is a rugged and resilient trauma patient simulator that was originally designed for teaching care on the battlefield. The simulator mimics an adult human, weighing 88 pounds and measuring 70 inches long. From a wireless tablet, HAL can be programmed to exhibit multiple neurological, airway, breathing, cardiac, circulation and trauma symptoms, including injury site arterial bleeding in the arm and/or leg

that is in synch with heart rate and blood pressure.

HAL's eyes open and close, and "he" has light-reactive pupils. His heart beats, he breathes and he can give pre-recorded verbal responses via streaming audio. Some

lungs, CPR and defibrillation.

Regardless of the symptoms HAL displays, he responds accordingly to the applied interventions, making him a safe and comprehensive training tool for clinical personnel. His durable construction can



of the other symptoms HAL is able to mimic include convulsions; secretions from the eyes, nose and mouth; and airway constriction.
